# Advancing Disability Inclusion in Very Small Businesses

March 25 - May 13, 2024



#### **Dialogue Summary**

From March 25 to May 13, 2024, the U.S. Department of Labor's (DOL) Office of Disability Employment Policy (ODEP) hosted the *Advancing Disability Inclusion in Very Small Businesses* national online dialogue. The online event gathered insights, experiences, and suggestions from a wide range of small business experts and interested members of the public—all designed to help DOL support small businesses with fewer than 50 employees in employing and retaining workers with disabilities, as well as disabled business owners and entrepreneurs. This report highlights the key themes and takeaways gleaned from the dialogue and summarizes the dialogue metrics.



## **Key Ideas from the Dialogue**


- ✓ **Broadening** and increasing support for small business owners in compliance with disability regulations.
- ✓ Creating grant programs specifically for disabled entrepreneurs.
- ✓ **Establishing** state-level entrepreneur centers and incubators.
- ✓ **Improving** support for disabled entrepreneurs, particularly on legal structure, financing, and business plans.
- ✓ **Increasing** and improving access to certifications, particularly from SBA.
- ✓ **Providing** financial assistance to cover initial hiring and onboarding costs such as training, workplace accommodations, insurance, and other associated expenses.
- ✓ **Simplifying** and expanding tax credits and access to support for disabled workers in the gig economy.

# **Informing Policy in Action**

ODEP has used input from this dialogue to support its technical assistance to Congress. This information has also informed resources that bolster small businesses' accessibility for people with disabilities. These initiatives include a series of webinars hosted by ODEP's Employer Assistance and Resource Network on Disability Inclusion (EARN), outreach to Native American disabled entrepreneurs, and the development of new technical assistance resources for small business owners. In addition, the dialogue guided ODEP's efforts to engage organizations serving the small business and entrepreneur communities.
